## Financial Assistance Program Plain Language Summary



#### **Overview:**

UHS, a not-for-profit acute care hospital, was established to serve the needs of the residents of New York and surrounding areas. The hospital is committed to providing medical services to patients regardless of their ability to pay. UHS recognizes that not all patients have the financial resources to pay their hospital bill. This Plain Language Summary provides a summary of our policy.

#### **UHS Financial Assistance Program (Charity Care)**

The Financial Assistance Program, also known as Charity Care, offers emergency and other medically necessary services at low or no cost to the patient. A discounted rate is applied automatically at the time of bill to uninsured individuals, if no application is received. If a Financial Assistance application is received, our staff will assist individuals in applying for eligible governmental health insurance programs, free of charge. Upon approval of the Financial Assistance application, individuals will receive the following discounts:

Annual Family Income	Amount of Discount
Less than 200% of FPG	100%
201% to 250% of FPG	83.5%
251% to 300% of FPG	67%

### This practice has adopted the following policies for charges for health care services.

We will charge persons receiving health services at the usual and customary rate prevailing in this area. Health services will be provided at no charge, or at a reduced charge, to persons unable to pay for services. In addition, persons will be charged for services to the extent that payment will be made by a third party authorized or under legal obligation to pay the charges.

We will not discriminate against any person receiving health services because of his/her inability to pay for services, or because payment for the health services will be made under Part A or B of Title XVIII ("Medicare") or Title XIX ("Medicaid") of the Social Security Act. We will accept assignment under the Social Security Act for all services for which payment may be made under Part B of Title XVIII ("Medicare") of the Act. We have an agreement with the state agency which administers the state plan for medical assistance under Title XIX ("Medicaid") of the Social Security Act to provide services to persons entitled to medical assistance under the plan.
